

Fall 2007 Brush Creek Mission Center Minutes
October 6, 2007

The Brush Creek Mission Center met in regular conference on October 6, 2007 for the Fall Conference at the Brush Creek Campgrounds. At the beginning of the conference, John Etcheson welcomed the conference, then Chris Ober read a scripture, followed by a prayer by Karen Witts. The conference then sang two hymns, "Great and Marvelous Are Thy Works" HS #48 and "Now in This Moment" HS #58. Richard Switzer brought the invocation.

Mission Center President John Etcheson then called the meeting to order. Attention was first turned to the 2006 Fall Conference minutes. Dale Warren moved to approve the minutes. The motion was seconded and carried by vote.

Chris Ober took the chair. She called attention to the letter in the bulletin from President Steve Veazey recommending that John Etcheson be sustained as Brush Creek Mission Center President.

John Etcheson made the recommendation that Chuck Knapp, Christine Ober, Richard Switzer, and Richard Streibich be sustained as counselors to the Mission Center President. John Etcheson also made the recommendation that Donna Bryant and Garry Rocket be sustained as MCFO. Mike Hodge made the motion to sustain them. The motion was seconded and carried by vote. Fred Keenan then presided over the election of the Ministry Endowment Fund Committee. Fred made the motion that the following be elected with their terms expiring December 31, 2010: Cleo Anderson, Rick Forth, Stephanie Gustav, Gordon Lambert, Chris Ober, and Glenn Webb. The motion was seconded and carried by vote.

Attention was then turned to the 2008 Brush Creek Mission Center Budget. Dale Warren made the motion to approve the budget. The motion was seconded. Discussion followed and Chris Ober amended the motion to increase the Youth/Young Adult Budget to \$4,000. The motion was seconded and vote carried. Glenn Webb made the motion to increase the assessment to cover \$4,000. The motion was seconded and vote carried. The vote for the 2008 Brush Creek Mission Center Budget was carried.

John Etcheson took the chair.

Steve Moore made the motion to sustain the Mission Center Appointments and recommended Dee Ann Hodge for office of Recorder of the Mission Center. The motion was seconded and carried by vote.

Mike Hodge made a motion to add Amanda Woodrow to the Youth Camp Committee. The motion was seconded and carried by vote.

Marvin Kleanau made a motion to sustain the Mission Center Council. The motion was seconded and carried by vote.

At this point, Donna Bryant and Garry Rockett brought offertory remarks to the conference. An offering was received. Conference broke for lunch and then convened.

John Etcheson brought the meeting back to order. The conference sang "Standing on the Promises" R#2.

John Etcheson handed out the Brush Creek Campground Profit and Loss sheet and the Brush Creek Campground Balance Sheet.

Fred Keenan then presided over the election of two new members for the Brush Creek Campground Board, which was voted by ballot. Steve Moore and Phil Houge were the new elected members.

John Etcheson then brought the following priesthood calls to the floor and the congregation was given the opportunity to share testimonies: Todd Haley to the office of Priest, Fairfield congregation; Eric Hampton called to the office of Priest, Martinsville congregation; Kara Johnson called to the office of Elder, Decatur congregation; Ellis Sills called to the office of Elder, Taylorville congregation; Doug Zaring called to office of Elder, Effingham congregation; Josh Zettler called to the office of Elder, Carbondale congregation.

Attention was then turned to new business. George Shafer made the motion for the Springfield Congregation property sale proceeds be split up 75% to Brushcreek Campground's and 25% to go to Brushcreek USA Mission Center. The motion was seconded. Discussion followed. Glenn Webb made an amendment to the motion for the proceeds to be distributed 80% to Brushcreek Campground's and 20% to Brushcreek USA Mission Center. The motion was seconded and vote passed.

Thirty people from the RV group and Mission Center helped install new concrete walkways and clean the campgrounds.

Glenn Webb made the motion to adjourn. The motion was seconded and carried by vote.

The congregation sang "Lord I Give, You" NS #32, and Ray Sills brought the prayer of benediction.
